

TRANSFER CHECKLIST FOR JUNIORS


Business Administration at UNC


Are you a junior transfer student interested in majoring in Business Administration (B.A) while at UNC-Chapel Hill? Here are a few helpful tips and recommendations:



Major Prerequisites // If you plan to transfer with junior status and graduate two years after transferring to UNC, these are courses that we recommend be completed prior to matriculating at UNC.

- ECON 101 (Must include both Microeconomics and Macroeconomics to transfer)
- ☐ ECON 410 (Intermediate Microeconomics Theory)
- ☐ ENGL 105 (English Composition and Rhetoric)
- ☐ STOR 155 (Introduction to Statistics)
- □ BUSI 101 (Managerial Accounting)
- ☐ MATH 231 and 232 (Both are required to satisfy the calculus prerequisite)
- ☐ Either of the following: MATH 152 or STOR 113





- □ BUSI 403 (Operations Management)
- ☐ BUSI 404 (Legal and Ethical Environment of Business)
- □ BUSI 405 (Leading and Managing)
- □ BUSI 406 (Principles of Marketing)**
- ☐ BUSI 407 (Financial Accounting and Analysis)
- □ BUSI 408 (Corporate Finance)**
- ☐ BUSI 410 (Business Analytical Applications)
- ☐ BUSI 411 (Strategic Management)
- ☐ 18 Business elective credit hours

**Junior transfers must take two core business courses in the first fall semester. To request a core business class, students must complete the non-business major request form found on the home page of the Undergraduate Business website. This form opens up at 8am the day before classes begin. Seats will be awarded on a first-come-first-serve basis. Those interested in Finance must include BUSI 408 as one of their two core classes; those interested in marketing must include BUSI 406. Failure to take two core classes during the first semester will make it challenging to complete the degree requirements in three semesters.

Note: students may have no more than one outstanding

prerequisite the semester they apply to Kenan-Flagler.



Frequently Asked Questions about transferring into Kenan-Flagler Undergraduate Programs

Q: What does it mean to be a junior transfer?

A junior transfer is defined as anyone transferring to UNC Chapel Hill entering their fifth term of residence in the fall semester, with 60 credit hours or more.

Q: Should I look at majoring or minoring in business?

Junior transfers are strongly encouraged to consider the undergraduate business minor over the major. It is much more reasonable for a junior transfer to be able to complete the requirements for the minor in their allotted four semesters, both in terms of prerequesites and core courses. Business minors receive all of the benefits as majors - the alumni network, access to our global program opportunities, career development initiatives and more - and minors achieve the same employment placement rates as majors.

Q: How hard is it to get into the Business School?

Approximately 50% of applicants are admitted each year. Given the competitive nature of the undergraduate business program, students who are currently enrolled in business programs at other four year institutions should think carefully about their decision to leave these programs.

Q: Do I apply directly to the Business program with my transfer application?

No. Transfer students must first be admitted through the UNC Undergraduate Admissions before applying to either the

Business major or minor. All students must spend at least one semester in the College of Arts and Science before they are eligible to start the business school. Students apply to business school early in their first semester at UNC.

Q: I'm planning out my courses - any advice?

Summer school might be a good option for some students as many of the prerequisites are offered in the summer months. We require that junior transfer students have one or fewer business school prerequisites remaining by the end of the UNC second summer session before they matriculate for the fall semester at UNC, as we do not admit junior transfer students with more than one remaining prerequisite on the fall UNC class schedule.

Q: Does UNC accept online transfer credit?

Yes, we accept online transfer credit from an equivalent Carolina Courses Online for all prerequisites except BUSI 101 Q: Are their other requirements or experiences that are strongly recommended?

The business school looks for well-rounded students who possess the following: depth of thought and intellectual curiosity, a global mindset, a clear rationale for why business, leadership potential, and motivation and drive. Extracurricular engagement and community service are highly valued as is real world experience. Students will need to provide an updated resume and submit three written essays as part of their application. Students are encouraged to participate in one or more mock interviews to prepare for the required admissions interview.

Q: How will I know how my courses transfer?

Most transfer equivalencies will be determined through Undergraduate Admissions - but please note that the business school makes all decisions on credit awarded for business courses taken at other institutions, and this process takes up to three weeks.

What is the deadline?

The deadline is September 1st, and the application opens July 1st.
